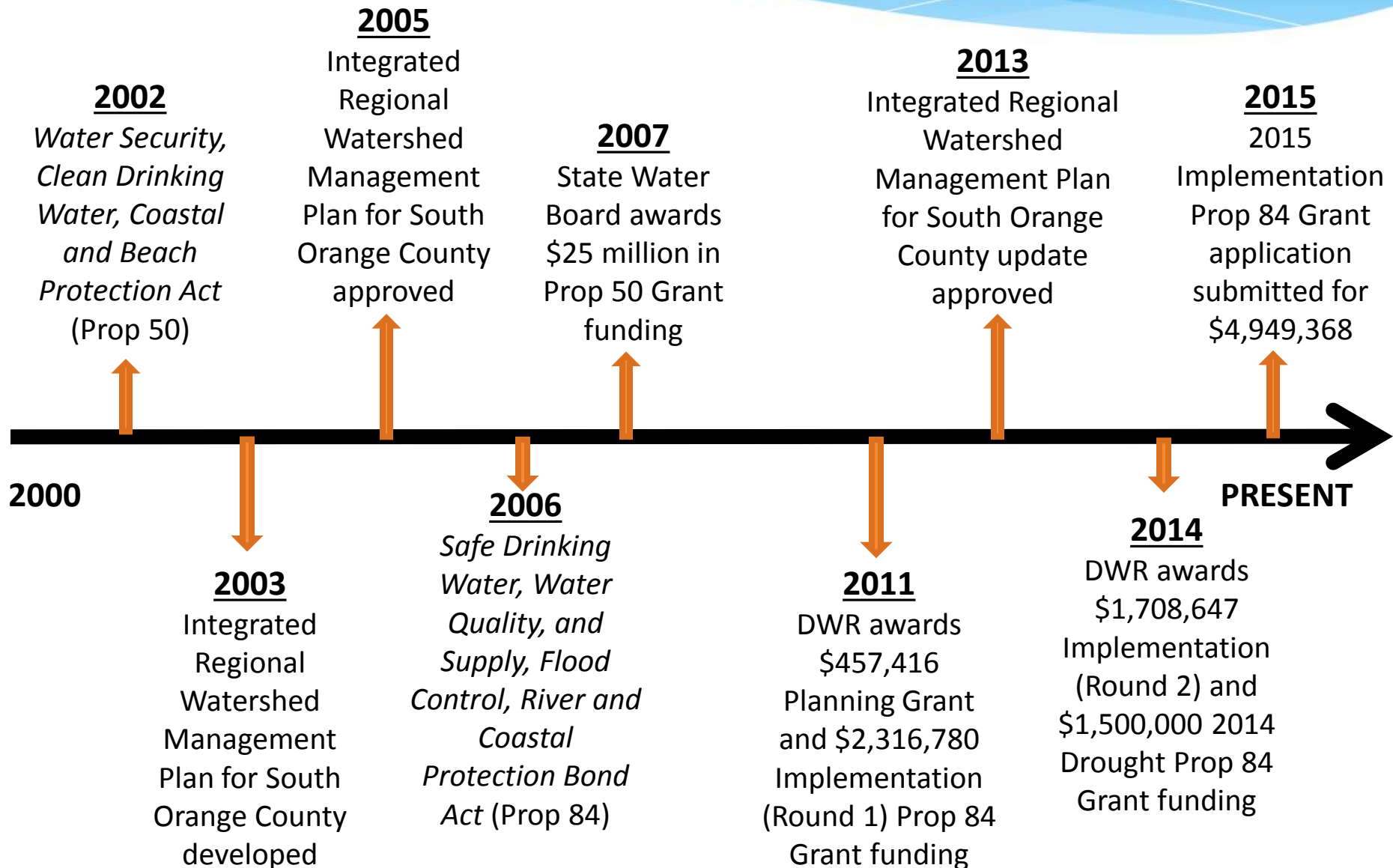

History of IRWM Grant Funding



| Grant | Total Funding |

| Proposition 84 2015 Implementation | \$4,949,368* |
| TOTAL FUNDING | \$35,932,211 |

Future of IRWM Grant Funding

- * Proposition 1 (Water Bond) passed in 2012 with approximately \$6.5 million for South Orange County – anticipated in two rounds (FY 2017-18 and FY 2019-2020)
- * Non-IRWM State grant funds will also be available through Prop 1 for Stormwater, Groundwater Management and Water Supply
