Dear Mr. Gibson:

The County of Orange and the Orange County Flood Control District ("County") submits this statement in its capacity as the principal permittee under RWQCB Order R9-2009-0002 ("Order") in accordance with Directive E.2 of the Permit Requirements of that Order. As you are aware, the County and a number of co-permittees are currently seeking review of certain portions of the Order, the outcome of which may alter its terms and conditions. Consequently, this statement is not nor should it be construed as a waiver of any rights the County may have to bring or maintain a legal challenge to the Order or to raise any factual or legal issues as part of any such challenge. The County hereby reserves any and all such rights.

1. Legal Authority Statement

The undersigned Supervising Deputy County Counsel for the County of Orange and the Orange County Flood Control District does hereby state that the County has or will timely obtain adequate legal authority to comply with the legal requirements imposed upon the County under RWQCB Order No. R9-2009-0002, consistent with the requirements set forth in the regulations to the Clean Water Act, 40 CFR [Code of Federal Regulations] 122.26(d)(2)(i)(A-F), and to the extent permitted by State and Federal law and subject to the limitations on municipal action under the California and United States Constitutions.

2. Status of Implementation

The County has not yet implemented some of the requirements imposed by the Order that have future effective dates. The County is also in the process of

amending its ordinances. The County has or will have adequate legal authority, as envisioned by the Clean Water Act and applicable regulations to implement such requirements by the mandated dates, and to enforce such additional requirements after they have been implemented when those ordinance revisions are final. The legal authority of the County is subject to limitations in California and federal law and subject to the limitations on municipal action under the constitutions of California and the United States. The exercise of its legal authority, therefore, is subject to those limitations.

3. County Departments

Attached is a table listing the County departments involved with the regulation of runoff along with a brief description of the department's runoff related functions. Generally, the County's jurisdiction is limited to the unincorporated areas of the County.

In some cases, such as the Public Health Officer function of the Health Care Agency ("HCA")/ Environmental Health, the County contracts with various cities to provide a governmental function within the incorporated city. The County official in that case is acting pursuant to a contract with the city and is enforcing city ordinances.

In some cases, County departments may be certified by the State to regulate certain activities. In these cases, the County department may have authority to regulate activities within incorporated cities as well as within the unincorporated areas of the County. They are, however, enforcing State statutes and regulations and *not* County requirements. The County Board of Supervisors cannot interfere with their statutory duties. Examples of such departments include the County Agricultural Commissioner/Sealer of Weights and Measures, a department within the County's OC Public Works agency; the Local Enforcement Agency, a function within the County HCA/Environmental Health that regulates solid waste handling and disposal activities; and the Certified Unified Program Agency also within the County HCA/Environmental Health, which regulates underground storage tanks as well as other aspects of petroleum and hazardous materials storage and release prevention and response planning.

4. Ordinances

List of Ordinances

Attached is a table listing the various County Ordinances related to runoff. These ordinances are generally applicable only within the unincorporated areas of the County. This list also identifies the County department principally responsible for assuring compliance with the ordinance.

Enforceability

The County has the authority under the Constitution and statutes of the State of California to enact and enforce ordinances. Ordinances listed in the attached table have been duly enacted by the County. These ordinances contain specific enforcement provisions such as the suspension and revocation of permits provisions in the Building Code and/or are enforceable under the generally applicable enforcement provisions of the County Code (Orange County Codified Ordinance (“OCCO”) Sec. 1-1-34 et seq. (misdemeanor), OCCO Sec. 1-1-40.1 (civil fine), and OCCO Sec. 1-1-40.13 (administrative penalties)).

Implementation and Challenge

Some of these ordinances are implemented through permit programs and some are implemented as regulatory programs. Under each ordinance, one or more County departments or department directors are authorized and directed in each ordinance to take the actions contemplated by the ordinance, *e.g.*, to consider evidence and make findings, to issue or deny permits, to impose conditions on projects, to inspect, to take enforcement action, etc.

The County Water Quality Ordinance is the principle County ordinance addressing runoff. This ordinance is regulatory, and applies to all development projects and to all new and existing facilities in the County's jurisdiction, whether or not a County permit or approval is required. The Water Quality Ordinance contains discharge prohibitions and BMP requirements. This ordinance also authorizes the County to require the submission of stormwater pollution prevention plans.

Other County ordinances require compliance with the Water Quality Ordinance as a condition for issuance of a County permit. For example, OC Planning is the County's planning department and is responsible for approving development and issuing grading and building permits within the unincorporated areas of the County. County departments may also impose specific conditions of approval consistent with the Water Quality Ordinance.

The California Environmental Quality Act (“CEQA”) applies to discretionary approvals by the County. CEQA requires the evaluation of the environmental impacts of a project before approval. This would include the impacts of the proposed project on water quality, including runoff.

Although proposed County ordinances are not subject to appeals, they are subject to a public notice and comment process prior to enactment. Enacted County ordinances can be challenged by timely filing writs of mandate in superior court. The referendum and initiative process can also be used to challenge enacted ordinances. The imposition of administrative

penalties and fines under these ordinances (where applicable) can be appealed to the courts. Trial court decisions to impose civil penalties or to grant injunctive or other relief can also be appealed.

In addition to the above authority, the County has in place the following legal and administrative procedures to assist in enforcing the various runoff related ordinances:


