PURPOSE:

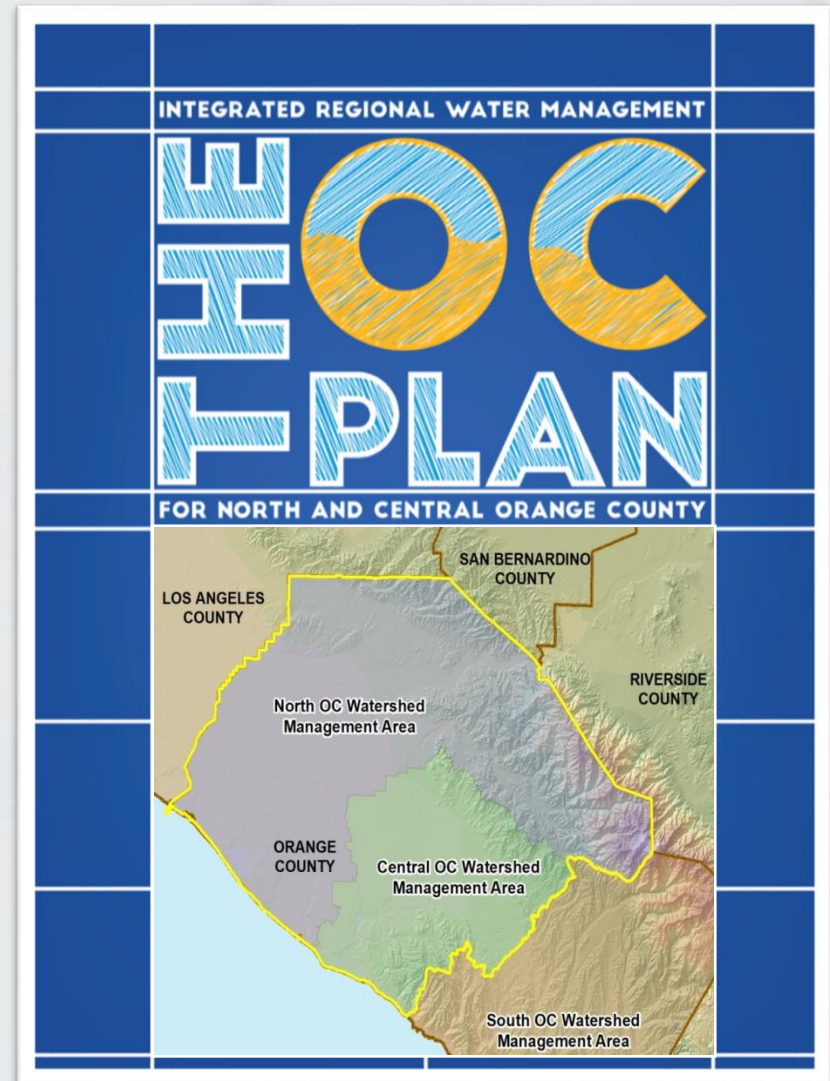
- Collaborate to identify water resource needs

- Project solicitation January 10 – February 21

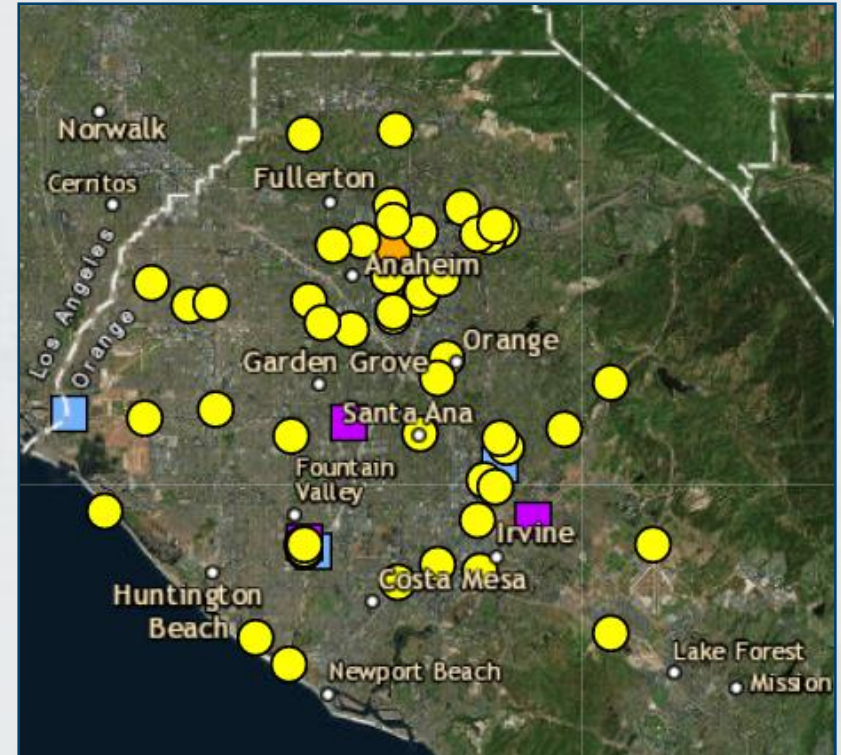

Recommended Action

- ➔ Recommend approval of the IRWM Plan by the aforementioned agencies
